**Minutes** – The reading of the minutes from the meeting was waived and Director Broadstreet made a motion to approve the minutes from the April 8, 2019 meeting, Director Blais seconded. Motion carried.

**Financials** – Chairman Novello presented the April financial report. The fund balances exceed the minimum reserve requirements by \$1,957,360 and the total receipts have exceeded the total expenditures to date by \$86,797. Unmetered collections are \$43 over budget and total operating expenditures are under budget by \$16,117. Director Blais made a motion to approve the financial report from April 2019, Director Ladd seconded. Motion carried.
