Weeds—Director Broadstreet stated that Aquatic Control treated 3.3 acres of milfoil on June 19th. DNR did not allow any native weeds to be treated. The annual survey will be done at the end of July from DNR. There is a list of safe products to use on weed control at the BLCD office, that homeowners can use in front of their home.

Tom Jordan's Report—Plant Manager Jordan mentioned that he and current homeowner by Lift Station E are discussing removal of a tree. Plant Manager Jordan also mentioned the rainfall for June was 3.90 inches and to date no muskrats have been trapped.
