Vice Chairman Collura made a motion to approve the bills as presented noting each payee, the dollar amounts, and purpose were read into the June 27, 2020 minutes, Director Ladd seconded. Motion carried.

Email Service—Vice Chairman Collura stated that currently we have about half the emails of the number of homeowners. A list of ways to collect more emails is in action. Next week training will begin for Chip Monkey to be able to launch the email service.

LARE—Director Broadstreet stated that the invasive vegetation treatment that took place on June 10th and takes three weeks to see results. He also mentioned that Aquatic Control would be out July 7th to follow up on how well the treatment took and what actions that will take place. Chairman Novello stated State Representative Gutwein was in touch with him and connected BLCD with a DNR representative for a conference call next week to discuss solutions for Bass Lake. Director Broadstreet stated that he would contact Aquatic Control to have to come to a future BLCD and/or BLPOA meeting.

Tom Jordan's Report—Plant Manger Jordan mentioned that the pump has been on since June 4th and 35 million gallons have been pumped into the lake.

Office Coordinator's Comments—Office Coordinator Dillner had nothing additional to add.

Comments from the Board—Vice Chairman Collura & Chairman Novello mentioned that three homeowner letters are attached to the minutes stating their concern for the invasive vegetation in Bass Lake (see attachments). These letters have also been forwarded on to our state representatives.

Attorney's Comments—Attorney had nothing additional to add.

Comments from the Audience—There was open discussion about the invasive vegetation between the audience and the board. It was agreed that a more productive discussion could take place at the BLCD meeting in August once they have the report back from the follow up survey that will be done on July 7.

Vice Chairman Collura made a motion to adjourn the meeting, Director Broadstreet seconded. Motion carried. The next meeting will be August 10, 2020 at 6:00 p.m. at the BLPOA building.
